# **Substantially Equivalent:**

If an applicant has been fully licensed in another state as a Licensed Professional Counselor (LPC) for less than 5 years, the applicant's supervised experience will be considered substantially equivalent for Louisiana licensure if the licensure requirements of the state in which they were licensed meets 75% of the direct, indirect, and supervision hours required by Louisiana law.

Effective April 1st, 2020 if a licensee is in LAPSED status, he/she will be required to submit to a fingerprint Criminal Records Check (CRC).

Effective January 20<sup>th</sup>, 2020 if a license is sanctioned the licensee will be asked to submit to a fingerprint Criminal Records Check (CRC).

Fingerprint results will be applicable for 90 days once received by the board office.
