Committee on Legislative Affairs Report: C Guillotte, J Mims, E Airhia, K Blum

Presented by K Blum-Planning to write bill about changing guidance counselor to school counselor this spring; Receiving questions from LPCs regarding what kind of

roles they can hold; Expand who can visit those in hospitals/ nursing homes. Need to provide low-cost counseling services.

J Mims- concerns about school counseling and ability to provide true counseling in a school setting. There is legislation that denotes that school counselors should be engaged in counseling. Asked Blum to follow up on it.

E Airhia- requests discussion on LDH proposal that LPCs may not diagnosis. J Doming- presents LDH rough draft of BHS manual that LPCs and LMFTs may not diagnosis for SMI.

K Blum- not aware of the manual.

C Guillotte- trying to institute SMI information printed is incorrect.

K Blum- only thing she can think of is that LDH is working from old rules.

J Mims- members of the Board are prohibited from lobbing but we can provide information. Can Board send letter to LDH reminding/ informing them that current legislation allows for diagnosis and SMI was removed from legislation. More importantly that our statue allows LPCs to diagnosis.
