**VOLUNTARY SURRENDER OF LICENSE**

**WHEREAS**, DAVID McMILLIAN (“MR. McMILLIAN”) is a Licensed Professional Counselor-Supervisor (“LPC-S”) and Licensed Marriage and Family Therapist (“LMFT”) and is subject to the jurisdiction and rules and regulations of the Louisiana Mental Health Counselor Licensing Act (La. R.S. 37:1101, et seq.), the Code of Conduct for Licensed Professional Counselors (LAC 46:LX § 2101, et seq.) and the Code of Ethics for Licensed Marriage and Family Therapists (LAC 46:LX § 2701, et seq.) and the rules regarding disciplinary proceedings (LAC 46:LX § 1301-1325, et seq. and LAC 46:LX § 3901, et seq.);

**WHEREAS**, the Louisiana Licensed Professional Counselors Board of Examiners (“LPCBE”), received information on February 5, 2020, alleging (1) that MR. McMILLIAN engaged in an inappropriate sexual relationship with the complainant, who was a former client, causing her undue harm; (2) that MR. McMILLIAN married the complainant after terminating his professional counseling relationship with her before a period of five years; (3) that he is currently engaged in an inappropriate sexual relationship with a former female client before a period of five years; and (4) that he billed for services not rendered and required clients to self-pay for counseling sessions, and then billed their insurance without refunding the client;

**WHEREAS**, by letter dated March 13, 2020, the LPCBE notified MR. McMILLIAN of the above mentioned complaint, provided MR. McMILLIAN with a summary of the nature of the complaint, and requested that MR. McMILLIAN, within thirty (30) days, provide a statement giving his review of the circumstances, which are the subject of the complaint;

**WHEREAS**, by letter dated April 13, 2020, MR. McMILLIAN responded to the complaint, giving his review of the circumstances that are the subject of the complaint;

**WHEREAS**, the respondent, MR. McMILLIAN, has indicated his desire to voluntarily surrender his licenses with the LPCBE, particularly LPC License No. 1744 and LMFT License No. MFT534;

**WHEREAS**, the respondent, DAVID McMILLIAN, LPC-S, LMFT, acknowledges that in accordance with the written policies of the LPCBE, the following will result due to his voluntary surrender of his LPC-S and LMFT licenses:

1. A report of this Voluntary Surrender of License and the conditions under which the license was surrendered shall be submitted to the National Practitioners Data Bank (“NPDB”).
2. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LPCBE website.
3. A two (2) year waiting period before MR. McMILLIAN will be eligible to apply for reinstatement with the LPCBE.
4. MR. McMILLIAN will be subject to prosecution of the pending disciplinary action at the time of reapplication or request for reinstatement as a LPC, LMFT, or upon application for any other credential issued by the LPCBE, as determined by the LPCBE.

WHEREAS, based upon the above, DAVID. McMILLIAN, LPC-S, LMFT, surrenders his licenses held with the LPCBE, particularly LPC License No. 1744 and LMFT License No. MFT534.
