Page 19 1 level psychology programs in Texas are typically longer 2 than the ones here in Louisiana. They're also quite 3 different in that the Texas ones are designed to prepare student for practice as Master-level providers and 5 clinicians. Because there is no Master's level license

7 to practice psychology here in Louisiana, students here do not have the same level in clinical training as they 9 do in Texas. My coursework and program in Texas did 10 train me to competently provide therapy. In the on-site 11 clinic at Lamar University, I saw clients of all ages and with a wide range of diagnoses and presenting 13 problems.
